• Spread word about who GSO is and what we do by handing out pamphlets, and our then PR Coordinator, Jeremy LaBorde, made a 3-D GSO logo out of materials he used for his thesis prototype.

- <u>Graduate Student Panel</u> in partnership with the Graduate School, showed undergraduate students how to best prepare for graduate school entrance tests on Thursday, March 30th.

Insiders Salon (April 25th)

 End of the semester social event at the Acadiana Center for the Arts which informed graduate students of their complementary ACA memberships for the duration of their degree at UL Lafayette and kicked off Festival International.

Advocacy

- Investigated graduate student concerns on rising health insurance costs for primarily international students and the lack of insurance for their dependents. Jennifer Kansas, a navigator with the Southwest Louisiana Area Health Education Center (SWLAHEC) presented in depth, who they are and what options cater to graduate students' needs:
 - Added a path to get to SWLAHEC resources on the GSO webpage.
 - The SWLAHEC Meeting Minutes, the second Advocacy meeting for Spring 2023, was shared with all four public colleges in Louisiana by Dr. Mary Farmer Kaiser.
 - Affordable health insurance for international students and their dependents can be found through a Marketplace plan while lawfully presiding in the U.S. These Marketplace plans utilize Tax Credits that can cover most insurance costs immediately after they apply.
- Connected with the Officer for Campus Diversity, Kiwana McClung in the Office of Campus Diversity, to discuss the movement on the plans for a Multicultural center and how it could aid in temporary international student housing.

Even after supplementing our initial budget of \$15,000 curated with student fees, with surplus funds of \$7,500, totaling \$22,500, we did not fund 9 applications some of which were ineligible. The eligible applications that were not funded totaled \$1494.00. Surplus funds of \$2338.09 were left in the research funds category and \$770.58 in the professional development category, totaling \$3108.67 in unused funds. After funding all the legitimate applications, we would be left with \$1,080.12 to go back into the GSO bank account.

We need to update our GSO bylaws to reroute all the surplus funds from the semester to be used in the travel category first, then every other category after that on a first come first serve basis. This is advised because we were not able to fund all the English department's programming application despite them being eligible for the funding they requested. This would be the last category considered for excess funds.
