- We do not dive into supplemental funding over the Summer Semester. Due to a much smaller Graduate Pool we incumbered \$5,700 in student fees.

Even though the encumbrance for the summer semester totaled \$5,700 with student fees alone, **exceeding the eligible need by \$1242.14** we were **not able to fund \$338** worth of travel requests. We pulled excess funds from the programming category to partially fund a travel request, but due to our bylaws, had to leave excess funds of \$1,003.89 in the research funding category and \$426.25 in the professional development category.

#### Fall Semester Objectives

- update our bylaws to use all excess funds on a first come first serve basis in all funding categories at the last general meeting.
- reconsider applications that didn't receive funding over the summer whether eligible or ineligible.
