 - a. Update to the Student Fees Waiver Situation
 - i. GSO Executive Board Meeting with Dean Farmer-Kaiser confirmed that our budget will not be reduced due to the loss of our funds via the Graduate Student's university fees.
 - b. Further update on Supplemental \$50,000 Fund
 - i. The funds are still mainly for use by PhD students, but they also exist outside GSO's jurisdiction.
 - This allows the GSO to restructure its own budget to serve Master's Students while pointing PhD Students to the \$50,000 Fund when applicable.
 - c. Public Relations Officer Nominees Tessa Rock, Jessica Ojadi, and Darian Cheramie.
 - i. President Okolo made quick introduction with discussion as to the vote held later for which of the three to take the position.
 - d. Bingo Night with Grad School Griffin Hall, Room 147 [5 7:30 PM]
- 5. Vice President's Report: Given by President Clement Tochukwu Okolo
 - a. VP Atif had Rep Grayson speak on behalf of Career Services to discuss the benefits of the organization.
 - i. Events such as All Majors Career Fair, Part-Time Job & Volunteer Fair, Resume Review, Education Interviewing Day, etc.
 - Dates and Times will be provided by Career Services
 - ii. Career Closet & Campus Cupboard

 - a. Status of current applications
 - i. Multiple new travel applications, but as of now the fund is \$8000 in the red
 - ii. Multiple Research and Supply Funds cannot be approved
 - Due to requests for books that cannot be approved due to damages incurred on the material during research.
 - b. Supplemental Budget \$8000 withdrawal recommendation from Funding Committee
 - i. Would be spread between the four categories by percentage of budget used by each section.
 - c. By Law Update Renaming "Programming" category to "Events" category
 - i. Hopefully clears up the use of the category so that applications begin to come in.

 - i. Motion to approve all travel applications save those that do not meet requirements
 - Seconded and Approved

 - iii. Motion to approve all Professional Development Applications save those that do not meet requirements
 - Seconded and Approved
 - iv. Motion to withdraw \$8,000 from GSO Savings to fund outstanding applications
 - Seconded and Approved
